The Motor Insurance Database (MID) is the central record of all insured vehicles in the UK. Please note that only the insurer responsible for the data can amend the data. If any data is inaccurate, please contact the insurer or organisation who has entered the data onto the database.

The easiest way to request the information the Motor Insurers' Bureau (MIB) holds on the MID regarding a deceased individual, an individual who is in ill health or any other individual who has provided relevant consent, is to complete the following Data Subject Access Request.

Please note, this request will not return any information relating to claims, written-off vehicles or 'No Claims Discounts'.
