To check free of charge if your vehicle is listed as insured on the MID, you can visit <u>www.askMID.com</u>. Please note that only the insurer responsible for the data can amend the data. If any data is inaccurate, please contact the insurer or organisation who has entered the data onto the database.

The easiest way to request the information the Motor Insurers' Bureau (MIB) holds about you regarding who you are insured with or have been insured with in the past seven years, is to complete the following Data Subject Access Request.
